Dear Govern or-Elect Newsom,

The California Democratic Rural Caucus is writing to propose a new position on your transition team and in the Governor's Office for a Special Advisor on Rural Interests.

This Special Advisor would formalize a voice for rural California, ensure that rural issues and concerns are addressed and that, in making statewide policy decisions, the question is raised: Is this fair and will it work in our rural California communities?
